WHEREAS, the Finance Committee has met and recommends the adoption of the Special Funds Budget for Fiscal Year 2009-2010; and

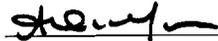
Therefore, be it resolved that the County Board of Macoupin County approve the attached Special Fund Budget for the 2009-2010 fiscal year.
